Lawn Irrigation:


State law: § 143-355.4. (Effective July 1, 2009) Water system efficiency.

(a) Local government water systems and large community water systems shall require separate meters for new in-ground irrigation systems that are connected to their systems.

New in-ground irrigation systems must be equipped with an above ground reduced pressure principle assembly backflow preventer

All backflow preventers shall be tested annually

Starting July 1, 2009 inspections of the BFP are required on all **new** systems



Do you know what Backflow is?

Water can flow both ways in a pipe. Under normal conditions water flows through the main lines, through the meter, then into the customers private system. When the pressure drops on the main line from a leak or hydrant being pulled too hard etc. the main line pressure can drop and the water will take the path of least resistance flowing from the private system back into the water system.



In order to camouflage your Backflow preventer:

-You can have the tap installed on the corner of your property instead of the middle of the yard.

- A bush or shrub may be planted between the road and the backflow preventer (leave plenty of access to the meter and BFP 3' minimum).

-Advances in enclosures in the past few years have made them more attractive.





Swimming Pools

- Swimming pools are considered hazardous to the water system.
- Please maintain an air gap while filling a swimming pool with a garden hose.



Well Connections

State regulations (Division of Environmental Health) **Do Not** allow a cross-connection between the potable (drinking) water and a private well. A valve that can be turned off is not considered a separation; a physical break in the piping is required.

Annual Testing:


Davidson Water, Inc. requires annual testing of all backflow preventers required by our cross-connection control policy. You must choose a tester from our list provided at www.davidsonwater.com. The tester will record the test on a form (also available from the site) and mail or fax the completed form to our office. Our staff will enter the information into a database for tracking purposes.



Frequently asked questions...???

- Do I have to get my Backflow preventer tested if I don't use my irrigation system very often?
 - Yes, if there is a connection to an irrigation system it must be maintained annually.
- 2. Who is certified to test my Backflow Preventer?
 - There are several testers approved by Davidson Water, Inc. you may visit our website for a complete list.

 - A physical break must be present between the water system and the irrigation system.
 - b. A Davidson Water, Inc. representative will inspect the separation.
